Standardization work in Finland is carried out in standardization groups open to everyone. Groups follow and participate in the development of European and global standards on their field. What is SFS Finnish Standards? SFS is the central standardization organisation in Finland.

<div class="df_qntext">Who approves and sells telecom standards in Finland?

In the International Telecommunication Union (ITU), Finland is represented by the Ministry of Transport and Communications. SFS approves and sells standards that are valid in Finland. There are currently around 30,000 such standards, most of which (about 97 percent as of 2024) are of European or international origin.

<div class="df_qntext">Who is responsible for information exchange in Finland?

In Finland, the Ministry of Economic Affairs and Employment is responsible for the information exchange systems specified in the TBT Agreement and required by the EU. Information exchange on standards has been entrusted to the WTO Enquiry Point at SFS.
