In total,financing for energy generation (low-carbon and fossil-based) accounts for less than 3%of BNP Paribas' total loans to the economy. The Bank is therefore not particularly dependent on the energy production sector,and the pace of its loan portfolio's transition is mainly linked to the real economy's transformation capabilities.

To support the energy transition,the BNP Paribas Group relies in particular on the Paris Agreement Capital Transition Assessment(PACTA) methodology.

This category first includes renewable energies, whose share of BNP Paribas' energy financing stocks is already higher than that of all fossil fuels; it also includes nuclear energy. The 80% target of financing going to low-carbon initially set for 2030 has been moved forward to 2028, with a goal of 90% by 2030.
