The Aug. 30 fire at the California Flats Energy Storage Project in a solar farm near Parkfield in southern Monterey County was extinguished within 24 hours, but monitoring is ongoing 24/7. The facility on the 92000 block of Turkey Flat Road, owned by Arizona-based Arevon, caught fire shortly after 11 am.

<div class="df_qntext">What happened to California's energy storage capacity?

The incident knocked out 2 per cent of California's energy storage capacity, which the state relies on as part of its transition to use more renewable power and less fossil fuels.

<div class="df_qntext">What happened at California's largest battery storage plant?

A fire at the world's largest battery storage plant in California destroyed 300 megawatts of energy storage, forced 1200 area residents to evacuate and released smoke plumes that could pose a health threat to humans and wildlife.
