<div class="df_qntext">Will the NDRC switch to a market-based bidding system?

<div class="df_qntext">What is NDRC & Nea energy plan?

The plan clearly states that energy authorities of provinces (autonomous regions, and municipalities directly under the Central Government) must implement the requirements of this plan, compile regulatory capacity construction plans for their respective regions, and submit them to the NDRC and NEA before the end of June 2025.

<div class="df_qntext">What will China's new PV projects look like in 2025?

Considering the impact of the new market-based transaction policy and other regulatory policies, China's new PV installations in 2025 are expected to be dominated by ground-mounted projects, which are expected to exceed 60%. Meanwhile, residential PV is likely to fall below 10%, with C&I projects stabilizing at around 30%.

<div class="df_qntext">Did China have a record increase in solar installations in 2024?

<div class="df_qntext">What impact does the NEA notice have on C&I projects?

Regarding C&I projects, in addition to the impact of the Notice on investment returns, the Management Measures for the Development and Construction of Distributed PV Power Generation (hereafter referred to as the Measures), issued by the NEA on January 23, 2025, exerts additional influences.

<div class="df_qntext">Which projects dominated Nea's project distribution in 2021 & 2022?

Regarding project distribution, based on the newly installed capacity data from 2018 to 2024 released by NEA, ground-mounted projects dominated most years, except for 2021 and 2022, when distributed PV accounted for more than 50%.
