<div class="df_qntext">What should a solar panel permit include?

The permit should include waste management protocols and measures to prevent contamination. All permits must be reviewed and signed by the site manager before work commences. Compliance with these permits is essential to ensure the safety of all personnel and the integrity of the solar panel works.

<div class="df_qntext">How do you inspect a solar panel system?

Ensure all personal protective equipment (PPE) is worn, including hard hats, safety boots, and high-visibility vests. Verify that the solar panel system is de-energised and locked out before commencing inspection. Conduct a visual inspection of all solar panels for any signs of damage, such as cracks or discolouration.

<div class="df_qntext">How do I protect my solar PV system from re-energisation?

Ensure all personnel are equipped with appropriate personal protective equipment (PPE), including hard hats, safety glasses, gloves, and safety footwear. Isolate the solar PV system from the electrical supply by switching off the main circuit breaker and locking it out to prevent accidental re-energisation.

<div class="df_qntext">What should be included in a PV system inspection?

Inspection of the PV system shall at least verify that: all circuits, protective devices, switches and terminals are suitably labelled to the requirements of IEC 60364 and SASO IEC 62548. All PV string combiner boxes carry a warning label indicating that active parts inside the boxes are fed from a PV array and may still be energized.

<div class="df_qntext">What are the requirements for delivery of solar panels?

All deliveries of solar panels and associated equipment shall be scheduled to minimise disruption and ensure efficient handling. Delivery vehicles must be directed to the designated unloading area by a competent banksman. The unloading area shall be clearly marked and free from obstructions to facilitate safe operations.

<div class="df_qntext">What is the initial risk of a solar panel installation?

Initial Risk: Catastrophic(5) x Probable (4) = High (20) Controls Ensure all operatives are trained and competent in the use of power tools specific to solar panel installation. Conduct a pre-use inspection of power tools to identify any defects or damage before commencing work.

If connection is made within the panelboard, ensure that the overcurrent protection is located at opposite end of bus from utility supply IF the sum of the current from both the PV and grid source exceed ...

A form indicating specific risks and onsite safety measures (see Annex A - Safety information Form) shall be filled and delivered by the Eligible Consumer/Contractor to SEC or to the concerned ...
