Manufacturers or distributors of products that are not CCC certified may also be subject to penalties. The CQC Mark is a voluntary product certification which covers more than 500 products,acknowledging that they conform with standards relating to quality,safety,environment,and performance.

To become certified, manufacturers must have their goods tested by laboratories and certification bodies that have been accredited by the Chinese authorities, such as the TÜV SÜD China Compulsory Certification and China Quality Certification centre in Beijing.
