<div class="df_qntext">Does CSC 1972 apply to international freight containers?

The requirements of CSC 1972 apply to the vast majority of freight containers used internationally. They do not apply to containers designed specifically for carriage by air.

IEC 60529 (IP ratings) and IEC 62485-5 address protection and operational safety. UL 1973, UL 9540A, RoHS, and REACH also remain applicable. Alignment with BIS-recognized testing laboratories is advisable, particularly for government or utility-scale deployments.
