CE marking is mandatory for many products before they can be sold in the EU. It indicates that a product has been assessed by the manufacturer and meets EU safety, health, and environmental protection requirements. This applies to products manufactured anywhere in the world that are then marketed in the EU.

Testing and Certification Services to the CE Mark CE stands for Conformit&#233; Europ&#233;enne, which translates from French to English as 'European Conformity'. CE certification is an EU safety directive that indicates that a product has passed certain tests and means that a product can legally be sold anywhere within the EU and the European Economic Area.

<div class="df\_qntext">Do all products have to be CE marked?

This also applies to products made in third countries which are sold in the EEA and Turkey. Not all products must bear the CE marking. Only those product categories subject to specific legislation are required to be CE marked. If there is no such requirement, the CE marking must not be affixed.

<div class="df\_qntext">Do solar panels need to be labelled and tested?

In addition, solar panels must be correctly labelled, documented, and tested. This guide explains how requirements from regulations and directives, such as the General Product Safety Regulation and the Low Voltage Directive, apply to solar panels sold in the European Union.
